THE PRESIDENT'S CORNER



Dear CMS community,

In this column, I summarize ongoing discussions within the CMS Executive Committee and the Committee on Finance and Budget regarding the financial health of our Society. Briefly, a significant portion of the Society's budget is covered by the return on its endowment. Over the last five years, changes associated with the evolution of publishing and with the Covid pandemic have caused significant

shifts in the Society's budget. At its current level, the operational budget deficit would gradually deplete the Society's endowment.

The Society's operational budget falls mostly under five categories: (i) contributions to/from members, (ii) the CMS Annual Meeting, (iii) the CMS Business Office, (iv) the Source Clays Repository, and (v) Clays and Clay Minerals and other publications. Item (i) has a small average deficit, i.e., the Society returns significantly more to members, in the form of student grants and other awards, than it receives in membership dues. Items (ii) and (iv) generate small revenue streams. Items (iii) and (v) (i.e., the operation of the Society and of its journal) represent the major expenses.

Several initiatives are being pursued to return the budget deficit to a sustainable level. The most notable one is that the Society transitioned Clays and Clay Minerals (CCM) to a joint publishing agreement with Cambridge University Press, instead of Springer, in January 2024. This is expected to alleviate the losses associated with publishing Clays and Clay Minerals. In addition, an Ad Hoc Financial Committee chaired by Jeff Greathouse has provided detailed recommendations in December 2023 on possible cost-cutting opportunities. The focus remains on trimming the budget deficit in the near term to ward off more significant cuts in the future. Meanwhile, please renew your membership, help recruit new members, submit a paper to CCM and encourage others to do so, attend a CMS meeting, and consider donating to maintain our financial viability.
